The applicant is hereby advised to obtain his/her own policy of insurance to provide coverage for any injuries to the person or property sustained by the applicant, guests, or inflicted upon other third parties as a result of the utilization of intoxicating liquors at the Borough Park by this permit. The applicant agrees to release and hold harmless the Borough of Alpha for any alcohol-related injuries to person or property, whether they be to the applicant, applicant’s guests, or third parties for the use and enjoyment of the Borough Pavilion on the date of said permit.

Applicant agrees to place garbage inside dumpster and hereby agrees to separate all recyclables and place next to dumpster. If applicant has not recycled and placed garbage in proper receptacles, a fine will be imposed not to exceed the maximum amount allowed by law. The applicant may face possible denial of future pavilion use.
